solemnly affirm and declare as under:

1. That I am the father/mother/legal guardian of Ms.

3. That my daughter/ward shall not leave the Hostel premises without obtaining prior written permission from the Hostel Warden/College Authorities. Any violation shall invite disciplinary action, including suspension or expulsion from the Hostel.
4. That my daughter/ward shall maintain proper discipline, decent behaviour and respect towards the Hostel Warden, Hostel Committee and Hostel staff, fellow residents and all Hostel property. She shall not indulge in ragging, bullying, violence, harassment, abusive behaviour or any act prejudicial to the discipline and reputation of the College/Hostel.
5. That my daughter shall not permit any outsider or unauthorized person to enter or stay in the Hostel room under any circumstances. Violation of this condition shall make her liable for strict disciplinary action.
6. That my daughter is medically fit and does not suffer from any contagious disease or any illness requiring constant parental care or special medical attention. Any change in her medical condition shall be immediately intimated to the Hostel Authorities.
7. That the College/Hostel Authorities shall not be responsible for any mishap, accident or incident occurring outside the College/Hostel premises. The parents/guardians shall be solely responsible for the safety and conduct of the student outside the campus.
8. That I fully understand and undertake that the Girls' Hostel follows a Zero-Tolerance Policy towards the consumption, possession, purchase, sale, distribution or use of alcohol, tobacco, cigarettes, e-cigarettes, narcotic drugs, intoxicating substances or any prohibited items, as well as involvement in any criminal, immoral, anti-social or unlawful activities. If my daughter is found involved in any such activity, the College/Hostel Authorities shall have the absolute right to expel her from the Hostel with immediate effect and initiate any disciplinary or legal action as deemed appropriate. I shall have no objection to such action, and the decision of the College/Hostel Authorities shall be final and binding.

9. That my daughter shall be responsible for any loss or damage caused to the Hostel building, furniture, electrical fittings, fixtures or any other College/ Hostel property. I undertake to bear the full cost of repair or replacement, as assessed by the College/Hostel Authorities.

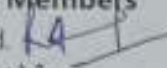

4. Affidavit: The prescribed language/format of the affidavit is available on the College website. The affidavit must be duly attested by a Notary Public. No affidavit in any other format or language will be accepted.
5. Presence of Parents: Parents must accompany the student at the time of hostel admission.

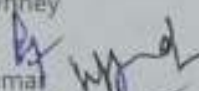

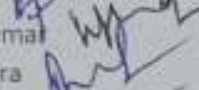

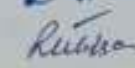
