As per Government Order no. 209-JK (HE) of 2026 dated 08.07.2026 and the AAY Fee waiver (operational) Guidelines, 2026, applications are invited from eligible students for the full fee waiver under the Antyodaya Anna Yojana (AAY) for the academic session 2026-27. Students belonging to AAY households and fulfilling the prescribed eligibility conditions are required to duly fill in the AAY fee Waiver application form and submit it along with the required documents.

Eligibility

1. The student is Bonafide student of the college enrolled in an undergraduate programme.
2. The student belongs to a household covered under (Antyodaya Anna Yojana) AAY and possesses a valid AAY ration card, confirmed from the records CAPD (food, Civil service and consumer affair Department) and having AAY Certificate.
3. The student is not receiving any other scholarship or financial assistance under any Central/State Government scheme, including the Post-Matric Scholarship Scheme (PMSS).
4. The applicant is a member of AAY household in question and applicants name figuring on the ration card, or the applicant's relationship to the head of the household being duly established.

- b) Original AAY Ration Card for verification
- c) Self-attested photocopy of the AAY Ration Card
- d) Aadhar Card/self-attested identity document
- e) College identity card
- f) University/College enrolment or registration Number
